What is a Bull Market?

- A bull market is a period of time in financial markets when the price of an asset or security rises continuously.
- The commonly accepted definition of a bull market is when stock prices rise by 20% after two declines of 20% each.
- A bull market is defined as a 20% gain or more in a stock market index or an individual security.
- The term "bull market" is typically reserved for extended periods in which a large portion of security prices are rising. Bull markets tend to last for months or even years.



Bull Market Characteristics

- Bull markets generally take place when the economy is strengthening or when it is already strong.
- Happens in line with strong gross domestic product (GDP) and a drop in unemployment and will often coincide with a rise in corporate profits.
- Investor confidence will also tend to climb throughout a bull market period.
- The overall demand for stocks will be positive, along with the overall tone of the market.
- General increase in the amount of IPO activity during bull markets.

The longest bull market in U.S. stock market history began in the depths of the financial crisis in 2009 and lasted almost exactly 11 years, until the COVID-19 pandemic brought it to a close.

Specifically, the widely followed S&P 500 index of stocks went from closing at a low of 676.53 points on March 9, 2009, to a peak of 3,386.15 on Feb. 19, 2020, which delivered gains of more than 400% across that period. (Note March 2009 time frame in the below chart)
